PLEASE NOTE

In line with Department of Education and Early Childhood Development guidelines we are requesting that the office sight a copy of your child's **birth certificate** (full or extract) and we need to sight or receive a copy of the **Certificate of Immunisation**.

When students are enrolled for the first time at the school, the child **must be enrolled in the name that appears on his/her birth certificate**. If the child was born outside Australia and a birth certificate cannot be produced, enrolment will be in the name indicated in a passport or on official travel documents.

The enrolment name may differ from the **name on the birth certificate** only:

- on production of a birth certificate which has been amended to another name
- production of a court order authorising the use of another name
- proof of adoption authorising the use of another name
- proof that the enrolling parent or child are subject to witness protection of similar.

All official school documents e.g. reports, will be issued in the name the child is enrolled under.

This confidential enrolment form asks for personal information about your child as well as family members and others that provide care for your child. The main purpose for collecting this information is so that Murtoa College can register your child and allocate staff and resources to provide for their educational and support needs. All staff at Murtoa College and the Department of Education & Early Childhood Development are required by law to protect the information provided by this enrolment form.

Health information is collected so that staff at Murtoa College can properly care for your child. This includes information about any medical condition or disability your child may have, medication your child may rely on while at school, any known allergies and contact details of your child's doctor. Murtoa College depends on you to provide all relevant health information because withholding some health information may put your child's health at risk.

Murtoa College requires information about all parents, guardians or carers so that we can take account of family arrangements. Family Court Orders setting out any access restrictions and parenting plans should be made available to Murtoa College. Please tell us as soon as possible about any changes to these arrangements. Please do not hesitate to contact the Principal, Mr Tony Goodwin, if you would like to discuss, in strict confidence, any matters relating to family arrangements.

Emergency Contacts

Student Background Information

COMPUTER AND INTERNET ACCESS: STUDENT CODE OF CONDUCT

Murtoa College is committed to offering opportunities to its students. Some of these opportunities relate to the use of computers and access to the Internet. The school has a computer network with in excess of 90 computers available for student use, linked to the Internet. In addition, all students are provided with an email account to send and receive electronic messages, hard disk space to save schoolwork and a printing allowance based on reasonable use.

The school believes that it is a privilege to be able to make use of computers, access the Internet and the resources on the school's network. As with all privileges they come with obligations and expectations of appropriate behaviour. The school makes use of a range of technologies to monitor student use. Electronic filters prevent access to pornography and other inappropriate sites on the Internet and vet email messages. Logs and audits track the sites that student's visit, the search terms used, and who has created files and so on.

This document informs both parents/guardians and students of the expectations that students must meet in order to access the school's network. It also makes parents/guardians and students aware of the level of supervision that the school will provide to ensure that students are making appropriate use of this resource. The signatures of the student and parent/guardian are required to ensure that everyone is aware of their rights and responsibilities. If students exceed their responsibility they will be dealt with within the school's discipline procedures.

HEAD LICE INSPECTION CONSENT

Permission to cover the duration of the student's schooling at Murtoa College

Throughout your child's schooling, the school will be arranging head lice inspections of students. The management of head lice infection works best when all children are involved in our screening program. The school is aware that this can be a sensitive issue and is committed to maintaining student confidentiality and avoiding stigmatisation.

The inspections of students will be conducted by a trained person approved by the principal and school council. Before any inspections are conducted the person conducting the inspections will explain to all students what is being done and why and it will be emphasised to students that the presence of head lice in their hair does not mean that their hair is less clean or well-kept than anyone else's. It will also be pointed out that head lice can be itchy and annoying and if you know you have got them, you can do something about it.

The person conducting the inspections will check through each student's hair to see if any lice or eggs are present. Person's authorised by the school principal may also visually check your child's hair for the present of head lice, when it is suspected that head lice may be present. They do not physically touch the child's head during a visual check.

In cases where head lice are found, the person inspecting the student will inform the student's teacher and the principal. The school will make appropriate contact with the parents/guardians/carers.

Please note that health regulations requires that where a child has head lice, that child should not return to school until appropriate treatment has commenced. The school may request the completion of an 'action taken' form which requires parents/guardians/carers to nominate if and when the treatment has started.
